1. TERMS OF REFERENCE (TOR) / SPECIFICATIONS

TO RENDER AUDITING SERVICES FOR CAPITAL INFRASTRUCTURE AND EFFICIENCY GRANT (CIEG) PROJECTS FOR WESTERN TVET COLLEGE FOR A PERIOD OF TWELVE (12) MONTHS.

Terms of reference

The objectives of the audit to test and confirm as per audit agreed procedures letter.

- The CIEG funding has indeed been applied for repairs and maintenance and not for any operational costs (validity)
- If quality of work has been delivered
- If reasonable rates have been charged by the Contractors for the work paid for
- If the projects were crucial and of important nature to the College, linked to maintenance plans of the College.
- If a Principal Agent or other Consultants have been appointed to facilitate the projects, to determine if the professional fees payable in this regard are market related.

Detailed Agreed-Upon Audit procedures:

- Sample a minimum of 5 CIEG projects completed by the Institution for each Bi-Annual audit.
- Obtain a detailed CIEG expenditure report from Financial System for the audit period under review.
- Obtain a listing of completed CIEG projects for the audit period under review, which must include the total value of expenditure incurred and paid for
- Based on the listing obtained, select a minimum of 5 projects based on total costs incurred (from highest reported expenditure in descending order)
- Trace all reported expenditure per listing, per project, back to the detailed expenditure report obtained from the College financial system.
- Randomly select minimum 5 transactions per project
- Perform a detailed audit check on the payments selected.

Conclude on the following audit assertions relating to:

- Occurrence
- Existence
- Accuracy
- Validity
- Completeness
- Valuation

Summary and Conclusion:

In total a maximum of 25 payment transactions (or less depending on the quantum of CIEG projects completed) will be applicable for each audit cycle.

Your firm must provide a conclusive AUP report indicating if the projects and transactions selected for the audit period under review, did fulfil the objectives as stated above.

The firm must raise any findings with college management and obtain management responses, clearing indicating the following:

3. Functionality Evaluation Criteria

- The below mentioned criteria regarding Functionality is required for responsiveness and therefore eligibility for the next stage of evaluation. This is done to determine the ability of each tenderer to successfully execute the contract according to specifications. Failure to score a minimum of 26 out of 44 points will lead to non-compliance and non-responsiveness.
- These criteria shall only determine whether a tender will further be evaluated and will not influence the points scored on Price.
- If any criterion is rated zero points, the tenderer will be rejected, even if the required 26 out of 44 points are achieved.
- For purposes of comparison and in order to ensure meaningful evaluation, bidders are requested to furnish detailed information in substantiation of compliance to functionality criteria mentioned and shall only determine whether a tender will further be evaluated.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to request a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
 - (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts.
 - (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- “tender for income-generating contracts”** means a written offer in the form determined by an

organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
- (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration.
- (g) **“consortium or joint venture”** means an association of person for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
- (h) **“contact”** means the agreement that results from the acceptance of a bid by an organ of state.
- (i) **“EME”** means an Exempted Micro Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, considering, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder.
- (l) **“non-firm prices”** means all prices other than “firm” prices; (m) **“person”** includes a juristic person.
- (n) **“QSE”** means a Qualifying Small Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad- Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003)
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of the bid invitations, and includes all applicable taxes and excise duties.
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to] support such primary contractor in the execution of part of a project in terms of the contract
