QUOTATIONS ARE HEREBY INVITED FROM EXPERIENCED, QUALIFIED AND REPUTABLE SERVICE PROVIDERS TO CONDUCT STUDENT REPRESENTATIVE COUNCIL (SRC) ELECTIONS, INDUCTION, AND FACILITATE CAPACITY BUILDING WORKSHOPS FOR A PERIOD OF THREE (3) YEARS.

a. ELECTORAL MANAGEMENT SERVICES

- The service provider must be capable and well equipped to manage SRC elections in accordance with the college SRC constitution as well as carry out SRC elections in a procedurally free and fair manner.

b. THE ELECTION ACTIVITIES WILL INCLUDE BUT NOT LIMITED TO THE FOLLOWING

- Appoint a Chief Electoral Officer who will be the liaison between the Service Provider and Westcol.
- Constituting the Electoral Commission.
- Appointment of Campus Election Presiding Officer for all Western TVET College campuses to coordinate and implement electoral processes.
- The Presiding Officer to maintain continuous liaison with interested students for the duration of the elections.
- Appointment and remuneration of election officials.

c. APPOINTING AN ADMINISTRATOR TO DEAL WITH THE DAY-TO-DAY ACTIVITIES RELATING TO ELECTIONS

- Ensuring that elections are conducted within the period as stipulated in the SRC Constitution or within the quarter of the year or whichever happens first.
- Work with the college in managing and marketing the SRC Elections (Publishing Voters roll, Election Timetable, Voting dates, Nomination Process, preliminary and final nominations, manifesto presentations, preliminary and final results) through posters and other related media.
- Facilitate information sharing sessions with students in preparation for the election processes.
- Handling the nomination process.
- The publication of candidates lists.
- Handling all objections and appeals related to the election process.
- Consulting with the Electoral commission in decision making if the need arise.
- Provide the necessary documentation to the Election Appeals tribunal should a matter be referred to the Tribunal (where necessary).
- Set up voting stations according to the prescripts of Electoral Procedures (campuses)
- Provide voting officials to manage the voting stations, which will be (1 Presiding officer, and other electoral staff) per voting station.
- The company will be required to provide electronic SRC voting platform (where necessary).

- The provision of all voting materials (voting booths, big boxes, numbered seals, demarcating tapes, rulers, pens, ink, stamps etc.) per voting station.
- The provisioning of colour printed ballot papers.
- Transportation and catering for voting officials.
- Ensuring a smooth voting process.
- The counting of ballots.
- Publication of preliminary and final results.
- Handling all objections from the nomination process to the publication of results.
- Declaring the results free and fair at the end of the process.
- Constitute the SRC in accordance with the SRC constitution.
- Provide an election and induction report within seven (7) working days of the completion of each election process (Campus and College SRC election processes).

1.4 The maximum points for this tender are allocated as follows:

	Points
Price	80
Specific Goals	20
Total Points for Price and Specific Goals	100

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to request a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
 - (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts.
 - (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- “tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts

through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
- (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration.
- (g) **“consortium or joint venture”** means an association of person for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
- (h) **“contact”** means the agreement that results from the acceptance of a bid by an organ of state.
- (i) **“EME”** means an Exempted Micro Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, considering, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder.
- (l) **“non-firm prices”** means all prices other than “firm” prices; (m) **“person”** includes a juristic person.
- (n) **“QSE”** means a Qualifying Small Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad- Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003)
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of the bid invitations, and includes all applicable taxes and excise duties.
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to] support such primary contractor in the execution of part of a project in terms of the contract
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9 (1) of the Broad-Based Economic Empowerment Act and promulgated in the Government Gazzetted on 9 February 2007.
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person.

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of:

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
