1. TERMS OF REFERENCE (TOR) / SPECIFICATIONS

1. PURPOSE

The purpose of these specifications or Terms of Reference is to invite qualified companies to procure and implement an ICT Lifecycle Asset Management Solution for Western TVET College. The solution must include a comprehensive laptop tracking and recovery system as part of a managed service. The total number of personal assets (laptops) to be managed under this solution is 372 units.

2. CURRENT SOLUTION

The College previously implemented an Information and Communication Technology (ICT) Device Tracking Tool as part of a managed service. This tool was designed to support remote data protection for personal assets, specifically laptops. Its primary functions included the ability to manage, monitor, track, and protect data in the event that a personal asset was lost or stolen.

3. CONTRACT PERIOD

The contract term shall commence on the date of award and shall remain in effect for three (3) years.

4. SCOPE OF WORK OVERVIEW

- ✓ The proposed solution should cover the following key components, Asset Inventory Management, Asset Assignment Tracking, Storeroom Management and Remote Data Protection.
- ✓ The service provider must install and configure the asset management, tracking, and recovery software following Western TVET College requirements and will be required to work with the college personnels and provide feedback to the relevant officials during installation and configuration.
- ✓ Include user identification details, physical locations, and status (In-stores, In-use, Retired, etc.) of the laptop.
- ✓ Asset Administration, the tool must provide an easy-to-use and cost-effective interface to maintain accurate laptop inventory data throughout the life cycle of the endpoint within Western TVET College through integration of the proposed tracking technology. This must include the ability but not limited to storeroom management, asset assignment to users and departments, and mobile scanning application. Integration capability of Asset Register and User information into a cloud-based management console. Retain a complete asset event history ensuring live and current auditing of devices in Western TVET College environment adhering to the PFMA and AG requirements.

- ✓ Data & Device Security, sensitive data is the intellectual property of Western TVET College and must be protected at all times, hence the software must have the capability to be accessed remotely to safeguard and protect data if at risk. Data that is at end-of-life must be able to be deleted/purged so that it is not accessible to unauthorized personnel. Audit logs and lifecycle certificates must be available as proof of data deletion/purging.
- ✓ Geotechnology, ability to track and trace, set physical locations to limit movement, creating controls of moveable assets (desktops and laptops will be defined differently). Functionality to track and recover assets all over the world. The ability to build geo-fences ensuring devices are only allowed within a pre-approved vicinity and creating alerts if a device moves out of the secure vicinity.
- ✓ The service must include ongoing maintenance and support for a period of three (3) years from the date of award.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 The applicable preference point system for this tender is the 80/20 preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to request a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts.
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.

- “tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
 - (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration.
 - (g) **“consortium or joint venture”** means an association of person for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
 - (h) **“contact”** means the agreement that results from the acceptance of a bid by an organ of state.
 - (i) **“EME”** means an Exempted Micro Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
 - (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, the execution of the contract;
 - (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, considering, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder.
 - (l) **“non-firm prices”** means all prices other than “firm” prices; (m) **“person”** includes a juristic person.
 - (n) **“QSE”** means a Qualifying Small Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad- Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003)
 - (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of the bid invitations, and includes all applicable taxes and excise duties.
 - (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to] support such primary contractor in the execution of part of a project in terms of the contract
 - (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9 (1) of the Broad-Based Economic Empowerment Act and promulgated in the Government Gazzetted on 9 February 2007.
 - (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person.

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of:

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
